You may know that Limassol has an agreement and a road map of actions to strengthen cooperation with St. Petersburg, the Northern Capital of Russia as it sometimes called. I have recently received an invitation from the Governor of St Petersburg Mr. Poltavchenko to visit the city in November. Together we shall celebrate the 5th anniversary of our formal agreement and follow up our plans and activities.
